RULES OF THE XXXVII JUAN BAUTISTA COMES CHORAL COMPOSITION CONTEST.

The Hon. Segorbe City Council announces the XXXVII Juan Bautista Comes Choral Composition Contest, in accordance with the following Bases:

FIRST.- OBJECT OF THE CALL AND REQUIREMENTS OF THE PARTICIPANTS.

The subject of the call is the diffusion of choral music as well as making known the compositional techniques currently used in choral polyphony and supporting the composers who cultivate this musical genre today.

Composers from all countries and all tendencies may take part in this Contest, as long as they are the author of the work presented and that it has not been awarded or distinguished in the last five editions of the contest.

Individuals who, complying with the specific participation requirements established, are involved in any of the causes of prohibition to receive subsidies established in article 13 of Law 38/2003, of November 17, General Subsidies, cannot participate.

SECOND.- WORK REQUIREMENTS.

The works must meet the following requirements:

- a) The works must be original and unpublished, having not received any other type of award and that they have not been performed in public or transmitted by any mass media, even fragmentarily.
- b). The work presented will be for a mixed "a cappella" choir with religious text in Latin, adjusted to a staff of 20 members, and a duration between a minimum of 6 and a maximum of approximately 9 minutes.
- c). The scores must have a clear layout.

THIRD.- FORM, PLACE AND DEADLINE FOR SUBMISSION OF THE WORKS.

The compositions will be presented under a motto, without a sign that allows them to identify their authorship.

Any self-citation or the appearance of information thanks to which the person who is the author of the original can be identified will lead to the exclusion of the work.

Works may be presented by any of the following means:

Two files will be attached in the email:

- The first one will contain the work and as a name it will carry the motto.
 - The second will be entitled PLICA. It will contain the registration form for the contest, according to Annex I, downloadable from the electronic headquarters of the Segorbe City Council (www.sede.segorbe.es) and from www.jjmmsegorbe.org/concurso-de-composicion/
- Submissions with incomplete or incorrect data and files as well as those that are damaged and do not allow the proper evaluation of the work presented will be automatically discarded. No communication will be maintained with the participating persons beyond the confirmation of receipt of the works in response to the sending email, which will constitute the justification of the presentation to the contest, once it has been verified that the documentation provided complies with the requirements established in these bases.

The escrow will only be opened if the work is a winner.

The period for submitting applications will begin on the day after the publication of the extract of these bases in the Official Gazette of the Province and will end on August 30, 2024, no work will be accepted outside this period. In the case of those sent by postal mail, only those envelopes whose postmark is dated equal to or prior to the end of the submission period will be accepted.

In no case will Segorbe's City Council be responsible for the loss or deterioration of the works that are sent by mail.

FOURTH.- PRIZE.

The procedure for granting this award will be competitive competition, by means of a convocatory for the presentation of the works.

A single prize of €2,100 is established, charged to item 11.3340.48900.73 RC 9055 of the current municipal budget. The prize will be subject to personal income tax withholding. If the winner is a professional of composing, the amount of VAT will be included in the amount allocated to the prize.

The award may be declared void if the qualifying jury considers that there is no work worthy of it.

FIFTH.- VALUATION CRITERIA.

The Jury will act with total independence and will determine the winning proposal based on the evaluation criteria and with the weighting indicated below, each of the proposals being able to be awarded a maximum of 40 points:

- Creative approach expressed in a personal language. From 0 to 10 points.
- Treatment of voice and choral writing. From 0 to 10 points.
- Coherence, proportion and balance in technical work and correct treatment of the text. From 0 to 10 points.
- Balance between difficulty and musical result. From 0 to 10 points.

SIXTH.- COMPETENT BODIES FOR THE INSTRUCTION AND RESOLUTION OF THE PROCEDURE.

The competent body for the instruction of this procedure is the Department of Culture of the City of Segorbe. The competent body for its resolution is the Mayor's Office.

SEVENTH.- QUALIFYING JURY.

The evaluation of the works presented will be made by a jury, chaired by the Mayoress, or a person delegated, and made up of 3 musicians of recognized prestige and 1 member of the Asociación Juventudes Musicales de Segorbe, who will act as Secretary.

The jury has the following powers:

- The power to declare the award void, justifying the reasons for this decision.
- The identification of the author of the selected work, by opening the plica.
- The interpretation of these rules and the resolution of any questions that may arise due to the contest.

EIGHTH.- CONCESSION PROCEDURE.

Once the admission period is over, the Jury will meet to evaluate the works presented and will prepare the proceedings, which will indicate:

- The admitted works, of those presented to the contest.
- Those not admitted, indicating the reasons for the exclusion.
- The evaluation of the works presented.

In view of the proceedings, the Department of Culture will issue a proposal, which will be binding on the competent body for the awarding of the award.

The result of the contest will be announced during the celebration of the Choral Festival concert cycle, and in any case before October 12, 2024, and it will be announced through the usual means: electronic headquarters (www.sede.segorbe.es) and other media of the Segorbe City Council and through the website of the Asociación Juventudes Musicales de Segorbe www.jjmmsegorbe.org.

This award will be incompatible with any other awarded for the same purpose and awarded by other Public Administrations and national or international public or private entities.

If, once the Contest has been resolved, it is justified that the winning work does not meet the conditions set out in the present convocatory, the author will be deprived of his/her prize.

NINTH.- RESIGNATION.

The presentation by the beneficiary, where appropriate, of the waiver of the awarded prize must be made within a non-extendable term of 5 business days from the day after receipt of the notification of the resolution agreement.

Notification of the resignation within this period constitutes an obligation of the beneficiary, for the purposes of the infraction and sanctions set out in Title IV of the General Law of Subsidies.

TENTH.- PAYMENT OF THE PRIZE.

The prize will be paid through bank transfer, into the account indicated by the beneficiary. It will be necessary for the winner to present a third party registration form at the City Council, duly completed, which will be provided by the City Council.

The award will be subject to current tax legislation, making the legally established withholdings. In order to regularize the taxation of the awarded prize and before paying it, the awarded person must inform the Department of Culture of the Segorbe City Council if their situation / professional activity is related to it.

Payment of the award will be made once all the procedures for its award have been completed.

ELEVENTH.- PREMIERE OF THE AWARDED WORK.

The award-winning work is expected to be premiered in the concert cycle of the XXXVIII Segorbe Choral Festival, which will take place in 2025.

TWELFTH.- EDITION.

The score of the winning composition will be published, with the corresponding reservation of authorship rights, in accordance with current legislation.

The winning person will have the right and the obligation to include on the cover of the score, books, CDs, records, concert programs, radio, television or cinematographic broadcasts, whenever the work is presented, both in Spain and abroad, the legend - "Juan Bautista Comes" AWARD of the XXXVII International Choral Composition Competition of Segorbe, Spain, 2024.

THIRTEENTH.- WITHDRAWAL OF NON-AWARDED WORKS.

The non-awarded works may be withdrawn by their authors or authorized persons within a maximum period of three months from the date of publication of the ruling, upon written request to the Department of Culture of the Segorbe City Council, prior to opening corresponding escrow to be able to record in them the name of the author. If they are not removed, they will become part of the Segorbe City Council archive.

FOURTEENTH.- PUBLICATION OF THE CALL.

An extract of this convocatory will be published in the Official Gazette of the Province of Castellón, publishing the full text of it in the Electronic Headquarters of the Segorbe City Council (www.sede.segorbe.es).

Likewise, an additional publication may be made in the form and by the means established by the competent body to carry out the convocatory.

The announcement of the convocatory in the Castellón BOP will be carried out through the National Subsidies Database in accordance with the provisions of article 20.8 a) of the General Subsidies Law.

FIFTEENTH.- ACCEPTANCE OF THE TERMS.

Participation in this Contest implies full acceptance of its bases.

In what is not expressly determined in these bases, the provisions of the LGS, its Regulations and the General Ordinance of Subsidies of the Segorbe City Council (BOP January 21, 2016) will govern.

SIXTEENTH.- DATA PROTECTION.

The personal data that will be provided in the application and in the documents provided, as well as those obtained throughout its processing, will be processed by the Segorbe City Council, as Data Controller, in order to process and manage the awarding of prizes.

The legal basis of legitimacy for the processing of personal data lies in art. 6.1.c) of the GDPR, the processing is necessary for compliance with a legal obligation applicable to the Controller. Art. 6.1.e) of the GDPR, the fulfillment of a mission carried out in the public interest or the exercise of public powers. And according to Law 38/2003, of November 17, General Subsidies, and Law 19/2013, of December 9, Transparency, access to public information and good governance. The data will be transferred by legal obligation, where appropriate, to the National Database of Subsidies, European Union Organizations, Courts and Tribunals, Tax Administration and Social Security, Court of Accounts and competent administration. The data will be kept during the period of time that the administrative file is in force or, where appropriate, for the time of resolution of a derived contentious administrative procedure. However, the data may be kept, where appropriate, for archiving purposes of public interest, scientific and historical research purposes or statistical purposes, and in any case for a minimum of 10 years from the end of the prohibition period, established in the Law Grants General. The owner of the data will guarantee the veracity of the data provided and will be solely responsible for the inaccurate or erroneous data provided and will undertake to communicate in writing any modification that occurs in them. You may exercise the rights of access, rectification, deletion, portability, limitation of treatment and/or opposition. For these purposes, you must submit a document in the Entry Register, electronic or in person, of the Segorbe City Council. In the letter you must specify which of these rights you request to be satisfied and, in turn, you must show or, in the case of postal delivery, accompany the photocopy of the ID or equivalent identification document. In the event that he acts through a representative, legal or voluntary, he must also provide a document proving the representation and identification document of the same. Likewise, if you consider your right to the protection of personal data violated, you may file a claim, first, with the corresponding Data Protection Delegate dpd@dipc.es or, where appropriate, with the Spanish Protection Agency of Data (www.aepd.es). In the event that the applicant provides data or documents with data from third parties other than himself, he must, prior to its inclusion, inform him of the ends contained in these Bases.
